Privacy & Cookie Policy

Social Buff Limited, trading as Threesixty Brands (registered number 11559804), whose registered office is at 22 Wenlock Road N1 7GU, knows that you care how your information is used and shared, and we appreciate your trust in us to do that carefully and sensibly. This notice describes our privacy policy and forms part of our website terms and conditions ('Website Terms').

By accepting our Website Terms or visiting threesixty-brands.com ('the Website'), you accept and consent to the practices described in this Privacy Policy.

The Website is brought to you by Social Buff Limited, trading as Threesixty Brands. Threesixty Brands believes it is important to protect your Personal Data (General Data Protection Regulation and the Data Protection Act 2018), and we are committed to giving you a personalised service that meets your needs and protects your privacy. This policy explains how we may collect Personal Data about you. It also explains some of the security measures we take to protect your Personal Data and tells you certain things we will and will not do. You should read this policy in conjunction with the Website Terms.

When we first obtain Personal Data from you, or when you take a new service or product from us, we will give you the opportunity to tell us if you do or do not want to receive information from us about other services or products (as applicable). You can normally do this by ticking a box on an application form or contract. You may change your mind by emailing us at the address below.

Some of the Personal Data we hold about you may be 'sensitive personal data' within the meaning of the General Data Protection Regulation and the Data Protection Act 2018, for example, information about your health or ethnic origin.

1. Collecting information

We may collect Personal Data about you from a number of sources, including the following:

- 1.1. when you agree to take a service or product from us, this may include your contact details, date of birth, how you will pay for the product or service and your bank details.
- 1.2. From you when you contact us with an enquiry or in response to a communication from us, in which case, this may tell us something about how you use our services.
- 1.3. From documents available to the public, such as the electoral register.

2. Using your personal information

2.1. Personal Data about our customers is an important part of our business, and we shall only use your Personal Data for the following purposes and shall not keep such Personal Data longer than is necessary to fulfil these purposes:

- 2.1.1. To help us to identify you when you contact us.
- 2.1.2. To help us identify accounts, services and/or products you could have from us or selected partners from time to time. We may do this automatically using a scoring system that uses the Personal Data you provided and/or any information we hold about you and Personal Data from third party agencies (including credit reference agencies).
- 2.1.3. To help us administer and contact you about improved administration of any accounts, services and products we have provided before, do provide now or will or may provide in the future.
- 2.1.4. To allow us to conduct marketing analysis and customer profiling (including transactional information) and conduct research, including creating statistical and testing information.
- 2.1.5. To help to prevent and detect fraud or loss.
- 2.1.6. To allow us to contact you in any way (including mail, email, telephone, visit, text or multimedia messages) about products and services offered by us and selected partners unless you have previously asked us not to do so.
- 2.1.7. We may monitor and record communications with you (including phone conversations and emails) for quality assurance and compliance.

2.1.8. We may check your details with fraud prevention agencies. If you provide false or inaccurate information and we suspect fraud, we will record this.

2.2. We will not disclose your Personal Data to any third party except in accordance with this Privacy Policy.

2.3. We may allow other people and organisations to use Personal Data we hold about you in the following circumstances:

2.3.1. If we, or substantially all of our assets, are acquired or are in the process of being acquired by a third party, in which case Personal Data held by us about our customers will be one of the transferred assets.

2.3.2. If we have been legitimately asked to provide information for legal or regulatory purposes or as part of legal or prospective legal proceedings.

2.3.3. We employ companies and individuals to perform functions on our behalf, and we may disclose your Personal Data to these parties for the purposes set out in clause 2.1 or, for example, for fulfilling orders, delivering packages, sending postal mail and email, removing repetitive information from customer lists, analysing data, providing marketing assistance, providing search results and links (including paid listings and links) and providing customer service. Those parties are bound by strict contractual provisions with us and only have access to Personal Data needed to perform their functions and may not use it for other purposes. Further, they must process the Personal Data in accordance with this Privacy Policy and as permitted by the General Data Protection Regulation and the Data Protection Act 2018. Occasionally, these other people and organisations to whom we may pass your Personal Data may be outside the European Economic Area. We will take all necessary steps to ensure that your Personal Data is treated securely and in accordance with this Privacy Policy, the General Data Protection Regulation, and the Data Protection Act 2018.

2.4. Where you give us Personal Data on behalf of someone else, you confirm that you have provided them with the information set out in this Privacy Policy and that they have not objected to such use of their Personal Data.

2.5. In connection with any transaction which we enter into with you:

2.5.1. We, and other companies in our group, may carry out credit and fraud prevention checks with one or more licensed credit reference and fraud prevention agencies. We and they may keep a

record of the search. Information held about you by these agencies may be linked to records relating to other people living at the same address with whom you are financially linked. These records will also be considered in credit and fraud prevention checks. Information from the application and payment details of your account will be recorded with one or more of these agencies and may be shared with other organisations to help make credit and insurance decisions about you and members of your household with whom you are financially linked and for debt collection and fraud prevention. This includes those who have moved house and who have missed payments.

2.5.2. If you provide false or inaccurate information to us and we suspect fraud, we will record this and may share it with other people and organisations. We, and other credit and insurance organisations, may also use technology to detect and prevent fraud.

3. Protecting information

We have strict security measures to protect Personal Data.

3.1. We protect your information's security during transmission using Secure Sockets Layer (SSL) software, which encrypts the information you input.

3.2. We reveal only the last four digits of your credit card numbers when confirming an order. Of course, we transmit the entire credit card number to the appropriate credit card company during order processing.

3.3. We maintain physical, electronic and procedural safeguards concerning collecting, storing and disclosing personally identifiable customer information. Our security procedures mean we may occasionally request proof of identity before disclosing personal information to you.

3.4. You must protect yourself against unauthorised access to your password and computer. Be sure to sign off when you finish using a shared computer.

4. The Internet

4.1. If you communicate with us using the Internet, we may occasionally email you about our services and products. When you first give us Personal Data through the Website, we will normally give you the opportunity to say whether you would prefer us not to contact you by email. You can also always send us an email (at the address set out below) at any time if you change your mind.

4.2. Please remember that communications over the internet, such as emails and webmails (messages sent through a website), are not secure unless they have been encrypted. Your communications may go through a number of countries before they are delivered – this is the nature of the Internet. We cannot accept responsibility for any unauthorised access or loss of Personal Data beyond our control.

5. Cookies

When we provide services, we want to make them easy, useful and reliable. This sometimes involves placing small amounts of information on your computer. These are called 'cookies'.

These cookies cannot be used to identify you personally and are used to improve services for you, for example, through:

- Letting you navigate between pages efficiently.
- Enabling a service to recognise your computer so you don't have to give the same information during one task.
- Recognising that you have already given a username and password, you don't need to enter it for every web page requested.
- Measuring how many people are using services, so they can be made easier to use and that there is enough capacity to ensure they are fast.

Users typically have the opportunity to set their browser to accept all or some cookies, to notify them when a cookie is issued, or not to receive cookies at any time. The last of these options means that personalised services cannot be provided, and the user may not be able to take full advantage of a website's features. We use AdRoll to provide interest-based advertisements to show our ads on other websites. The technology to do this is made possible by cookies, and as such, we may place a so-called "remarketing cookie" during your visit. The whole process is entirely anonymised. This is a first-party cookie.

_ga

The Google Analytics library uses this cookie to store a unique client identifier (Client ID), a randomly generated number. Once the ID is generated, it's stored in the cookie and is included with each hit/request sent to Google Analytics. This ID is later used by Google Analytics servers to calculate user, session, and campaign data. This is a first-party cookie.

_gat

We use Google Analytics to assist with monitoring and identifying areas of the site that can be improved. Your personal details are not tracked. The _gat cookie is used to throttle the request rate back to Google. This is a first-party cookie.

By using this website, you agree that we can place these types of cookies on your device.
